



## Terms of Use & Rules

The use of the high ropes course is associated with risks. **Before use, each participant must read the Terms of Use & Rules.** The observance of the conditions of use is the responsibility of the user. With his signature, the participant confirms that he has understood the conditions and accepts them without reservation. The legal guardians of underage participants are solely responsible for the supervision during the visit and the accompaniment while walking the high ropes course. With their signature, the legal guardians confirm that they have internalized the terms of use together with the minors and are solely responsible for them in the area of the high ropes course. Admission prices as posted apply.

### **Allowed users:**

**Children aged 6-8 years** may use the green course and the climbing tower when accompanied by an adult supervisor. The minimum size is 120 cm. The supervisor has to climb with you.

**Children aged 9-13** and a minimum height of 140 cm may use green, blue and red courses and the climbing tower when accompanied by an adult supervisor (does not have to climb with them).

**The following applies to the supervisor:** a maximum of three children are permitted per accompanying person (group regulations on request). The accompanying person can climb with you! The accompaniment must stay in the high ropes course and observe and look after the children to be supervised from the ground.

**Young people between the ages of 14 and 17** may only use all courses with the consent of a legal guardian (visitor form).

**Adult course (black):** from 14 years and 160 cm minimum height. Maximum weight with clothing and equipment (approx. 5kg): 120 kg.

Persons who suffer from an illness that could pose a danger to themselves or others when using the Hürtgenwald high ropes course, who are under the influence of alcohol or other drugs are not authorized to use the climbing park. Prohibited items: When using the Hürtgenwald high ropes course, no items may be carried that could pose a danger to the user or other people. This includes in particular jewellery, mobile phones or cameras.

**Before using the Hürtgenwald high ropes course, each user must take part in the theoretical and practical safety demonstration.**

**Here are the most important key points to be observed when using the climbing forest:**

**-The safety system (Edelrid Smart Belay) may only be closed in the safety rope provided (marked with colored cubes), on the aft (rings on the ascents and descents + Topaz system on the climbing tower) and on the exit hook on the ground. Under no circumstances may it be manipulated (closing the open carabiner with a finger, branch, hanging on a climbing harness or other foreign body) is absolutely forbidden!!!**

*-Only one person may be in a climbing element or in a cable car with his safety system, the climbing elements may under no circumstances be used as a cable car!!!*

*- A maximum of 3 people may be on the platforms on the tree, all of whom must be attached to the intermediate tree safety ring with both carabiners if the adjoining climbing element is occupied.*

**- Before using the cable cars, make sure that nobody is in the landing area! Always stretch your legs forward during the flight phase!**

**-If help is needed, call the trainer (yell STOP loudly!), do not try to save yourself.**

*-The equipment (full harness, safety system and helmet) must be used according to the instructions of the staff and must be treated with care.*

*The instructions of the staff must be followed at all times. Users who violate the rules of use or the instructions of the staff can be excluded from the Hürtgenwald high ropes course. In this case, the excluded visitor is not entitled to a refund of the entrance fee. The operator reserves the right to stop operations for safety reasons (e.g. fire, storm, thunderstorm). In this case, the user receives a time credit.*

**If you are unsure about how to use it, please ask a trainer for help immediately!**

**Smoking is prohibited in the climbing harness and in the entire area of the Hürtgenwald high ropes course!**

*Copyright: The operator reserves the right to take photos, films or webcam recordings throughout the climbing forest and to use these for advertising and information purposes. The user who does not agree to this must notify the staff before use.*

*Liability Access to the facility and grounds is at your own risk. In the event of property damage and financial loss, the operator is only liable in the event of gross negligence on the part of the staff. The Hochseilgarten Hürtgenwald GbR assumes no liability for damage or accidents caused by non-compliance with the terms of use or incorrect information. No liability for the storage of personal items.*
